Developing your Training Program (cnt.)

What is the goal of the response?

- ☐ Create an orderly/contained response
- Creating harder targets (lockdown)
- Stop the threat from gaining entry (controlled access)

What training do we conduct? Active shooter what else?

Developing your Training Program (cnt.)

Training required for appropriate response

Staff training for de-escalation of situations

School Resource Officer is familiar with students and staff

Partnerships with local law enforcement and fire departments

Performing live exercises with all involved

Developing Your Training Program (cnt.)

Where is the threat or the response required?

Front office/main entrance

Classroom

Gym, auditorium, restroom or cafeteria

Outdoors/off campus activities

Assembling and Staffing Your Teams

Oversight of teams is responsibility of the district safety team

Building Specific Training vs District Training

Identify skills of available staff

Identify leaders

Continuous Training

Have a professional training program in place (continuous education)

Meet with community and emergency responders on a regular basis

Run exercises often (realistic scenarios)

Challenge your staff

WISCONSIN LEGISLATIVE COUNCIL ACT MEMO

2017 Wisconsin Act 143 [2017 Assembly Bill 843] Office of School Safety and School Safety Grants

2017 Wisconsin Act 143 creates an Office of School Safety, establishes school safety grants, makes changes related to school safety plans, and requires mandatory reporting of threats of school violence. The Act also includes remedial changes introduced by the Joint Legislative Council's Law Revision Committee at the request of the Department of Public Instruction (DPI).
